## **ODOR RECOGNITION TESTS**

Odors: Clove, Birch, Anise

**Sunday, November 25<sup>th</sup>, 2018**



Think Pawsitive's ORT will be held indoors on artificial soccer turf. The test is on the first floor of our facility. Parking is plentiful and it is easy to navigate from the parking lot and crating area with nice flow to the ORT testing area with no issues.

***Entry method - First received by USPS Mail.  
Overnight deliveries must have the signature waived box checked.***

***Entries close November 17<sup>th</sup>, 2018 at 6:00pm or when entry limits have been met.***

***Entries are LIMITED to 100 tests.***

Test Site Hours: 8:30am-3:00 pm. Check-in and Handler Briefing details will be sent out in the final confirmation email approximately 1 week before the ORT.

**There will be separate check-in times for anise and clove.**

### **Test Site Information**

The ORT will be indoors on artificial turf. Restrooms are available inside. Limited indoor crating available. Dogs may remain in the car. Food will not be available. There are several restaurants within a 1-mile radius. All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; flexi-leashes may be used in the test itself. Please clean up after your dog and respect the marked potty areas.

### **Entry Requirements**

The handler of the dog must be a current member of the NACSW™.  
The Dog must be registered with the NACSW™.

### **Trial Eligibility and ORTs**

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

### **Entry Fee and Second Dog Policy**

**\$35.00 per dog, per odor.** Maximum of 2 dogs per odor per handler. A separate entry must be submitted for each dog.

### **Closing Date**

**Entries close November 17<sup>th</sup>, 2018 at 6:00pm**

Overnight mail entries must have the signature request waived.

### **Refund Policy**

Cancellations received via email by 6:00pm central time on June 23<sup>rd</sup>, 2018 will be issued a refund minus a \$5.00 processing fee. **No refunds after November 17<sup>th</sup>, 2018.** The secretary is not responsible for lost emails. The secretary will send an email confirming the cancellation within 48 hours of request. ENTRY FEES shall **not** be refunded in the event that a dog is absent, disqualified or excused by the NACSW official or judge.

### **Video/Photography Policy**

ORT participants are allowed to have a friend or family member video/photograph their test.  
ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph.

### **TEST Information - Notice to Exhibitors**

**THE TEST SITE** will be open from 8:30am-3:00pm.

**CHECK-IN AND HANDLER BRIEFING: 8:30am – 9:00am.** Check-in and Handler Briefing details will be sent out in the final confirmation email approximately 1 week before the ORT.

**An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.**

**Scorebooks are optional and are not required to participate in an ORT.** They are for personal record keeping. If you have lost a scorebook or would like a replacement, you can request a replacement scorebook that will include all your prior NACSW results. Log in to your account at: <http://www.nacsw.net> and under the "My Account" section, go to "My Dogs" and choose the option to order a replacement scorebook there. The cost is \$20.

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

## **ENTRIES:**

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times. There is inside crating available at this test site.

**FEMALES IN SEASON - Contact your test host at least one (1) day before the ORT if this becomes a possibility.**

**REACTIVE DOGS** - Please contact [Katie@thinkpawsitivedog.com](mailto:Katie@thinkpawsitivedog.com) if your dog is reactive to other dogs and will need a red bandana during the ORT. All reactive dogs will need to be crated in your car; no inside crating will be available.

**DOGS PARTICIPATING** in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

**Acknowledgement of entry acceptance/CONFIRMATION** will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

**BASIC DESCRIPTION OF TEST** – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an “alert” within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows, spaced a minimum of 48” apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.
