



Think Pawsitive Agility Turf Rental Door Access Card

User Acceptance Agreement

This agreement outlines the responsibilities I have as a holder of the Think Pawsitive Turf Rental (TPTRA) Door Access Card. My acceptance of this agreement indicates that I have read and understand the Identification/Access Card Policy, and agree to adhere to the protocol and procedures established for Door Access Cards.

1. The Door Access Card is intended to facilitate the entry into Think Pawsitive and to electronically access the agility turf for agility skills practice rentals.
2. I understand that the Door Access Card is issued in my name as the sole authorized person for access to the appropriate areas of Think Pawsitive turf arena. I will not allow any other person to use my Card. I understand that I should not open the door for others that do not have their own card.
3. All questions need to be directed to management of Think Pawsitive through the main entrance of 301 Commerce St. Suite F, Waukesha, WI 53186.
4. A security deposit of \$25.00 is required to obtain an Agility Turf Rental Access Card for your scheduled agility turf rentals.
5. I understand that upon termination of my contract or volunteer/special services, my card must be returned to the Think Pawsitive Management team. The \$25 security deposit will be returned via check. The check will be sent 1-2 weeks after the card is returned in original condition.
6. Please park in the labeled parking for your Agility Turf Rental Access in our Reserved Lot in the back of Think Pawsitive. All agility turf rentals with door access cards are limited to a maximum of three participants and all of the participants must have signed a liability waiver prior to your scheduled agility turf rental door access time.
7. I will not prop open doors or garages, as this will activate a security alert.
8. I will not punch holes in the card, attach or affix any pins or decorations to the card, bend the card, label the card with facility name or wash the card as it may render the card inoperable.
9. I understand that cards should not be left unattended on cabinets, shelves, chairs, dog crates, or carried in such a manner to be susceptible to loss or theft.
10. I understand that visitor cards may be issued to eligible persons for a limited time period (e.g., when an individual provides volunteer or special services), and must be returned to the issuing manager or staff member by the end of the authorized period.

11. I understand that upon termination of contract or volunteer/special services, my card must be returned to the Think Pawsitive Management team.
12. I understand that I must immediately notify Katie Oilschlager (katie@thinkpawsitivedog.com) if my Think Pawsitive Agility Turf Rental Identification Card/Access Card is lost, missing, stolen, or damaged.
13. I understand that the Think Pawsitive management team will assess individuals a non-refundable fee of \$15.00 for a replacement card if their card was lost, missing or damaged.

Rights of the Think Pawsitive Agility Turf Arena

The Door Access Card remains the property of the Think Pawsitive Dog Training LLC at all times. Think Pawsitive Dog Training reserves the right to withdraw from an individual, any or all of the facilities of the Card and to request that the Card be surrendered if evidence is found that the Card is being misused in any way. Any unauthorized use will result in confiscation and or disciplinary action. Think Pawsitive Dog Training reserves the right to withdraw all Door Access Cards, suspend some or all of the facilities or replace the Card with one or more alternatives, without prior notice.
