Final Details for CPE Canine Scent Sport Trial

Thank you for entering **Think Pawsitive Dog Training's October 12-13, 2025 CPE Canine Scent Sport trial!**Please check all your information carefully, and if any errors are found, please email Katie Oilschlager immediately at katie@thinkpawsitivedog.com.

NOTE: The trial will be held at Washington County Fairgrounds, 3000 County Hwy PV, West Bend, WI 53095 Enter the fairgrounds off Hwy P through Gate 11. This is located on the north end of the fairgrounds. The main lot will not be available during this event.

Thank you to all who have volunteered to work! If you would like to work and did not send a worker form with your entry, please get in touch with Katie at katie@thinkpawsitivedog.com, and we will adjust the schedule accordingly. Lunch, snacks, and beverages will be provided for workers only. Thank you to everyone who signs up to volunteer!!

PARKING: There is space for RVs to park in the competitor parking area during the trial day. To reserve a space, you will need to contact the host after you receive confirmation that you have received a space in the trial. Email katie@thinkpawsitivedog.com to reserve RV space. **No overnight RV parking is available.** There is ample parking for those wishing to run their vehicles or generators during the day. There will be NO reactive dog parking at this trial. There will NOT be separate potty areas or warm-up boxes. **Please do not arrive before 7:30 am.**



CRATING: Crating is only allowed in your vehicles. No indoor crating will be provided. **POTTY AREA:** Please stay in the designated potty areas and clean up after your dogs.

RESTROOMS: Located as marked on the map (above).

CHECK-IN: 7:45 to 8:00 am, and the first dog on the line will be at 8:30 am.

GENERAL BRIEFING: This will happen by 8:15 am. Please read through this document for all the details.

WALK-THROUGHS: Walk-throughs will be at the discretion of the judges.

RUNNING ORDER will be as follows:

Sunday - Eric Burknap: Interiors Rd1, Containers Rd1, Exteriors Rd1, Vehicles Rd1

- Kevin Korthas: Containers Rd2, Containers Rd3, Exteriors Rd2, Exteriors Rd3

Monday - Eric Burknap: Containers Rd1, Containers Rd2, Exteriors Rd1, Exteriors Rd2

<u>On Sunday</u>: Levels 5 and C will start all elements. The first four searches will be run before switching to the remaining four searches. The remaining levels will follow in order and may run consecutively with another level.

On Monday: Level 1 will start all elements

CHECK-IN & RUNNING ORDERS: We will have running orders posted on Agility Gate. There will be Gate Stewards to help you. If you have a conflict, please let them know so they can adjust accordingly.

WE WILL BE USING THE AGILITY GATE APP - https://agilitygate.com/ (Code is 1012): Agility Gate is a free-to-download app that allows competitors to check in their dogs at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring.

PRACTICE BOXES: Will be made available before your search. These will be located near the entry of the search area. There will be staging spots, and the practice boxes will be near your first staging location.

JUDGE'S CLASS BRIEFINGS: The judges will provide an overview of your searches around 8:15 am. This briefing will include the total time allowed per search and the number of hides, if known. Please read the rule book before the trial to familiarize yourself with the requirements for your level to qualify.

ENTERING AND EXITING THE SEARCH AREAS: Signs and soccer dots will be provided to show the locations to enter each search area. Volunteers will assist should you have any questions.

PHOTOGRAPHER: Kazik from Turek Studio will be capturing your performances on Sunday, October 12th.

RESULTS AND RIBBONS: The location of the trial results will be discussed during the general briefing. Trial results will be posted in the trial result book, and ribbons will be available at a self-serve station. Score stickers will be provided, allowing you to easily place them on your ribbons. If you and your dog are working toward a championship, please let us know—we would love the opportunity to celebrate this special milestone with you! For any move-ups needed for the following day, record your information on the move-up sheet located next to the trial result book.

DIRECTIONS:

From Milwaukee:

Follow I-94 W. Use the right 3 lanes to take exit 305 A-305 B to merge onto I-41/US-45 N toward Fond du Lac (3.7 mi). Keep left to continue on I-41 (16.4 mi). Use the right 2 lanes to turn slightly right onto US-45 N (signs for West Bend) (5.6 mi). Take exit 65 to merge onto Pleasant Valley Rd (0.3 mi). Merge onto Pleasant Valley Rd (0.4 mi). At the traffic circle, take the 3rd exit onto Co Hwy P/Co Rd P (0.2 mi) to Washington County Fair Park, 3000 Cty Hwy PV, West Bend, WI 53095

From Madison:

Take US-151 N toward Sun Prairie (18.6 mi). Take exit 115 for WI-73 N toward US-151 BUS/Columbus (0.4 mi). Take a slight right onto US-151 BUS/WI-73 N (2.0 mi). Turn right onto E James St (0.3 mi). Take a slight left onto WI-60 Trunk E/E James St/Manning St. Follow WI-60 Trunk E for 28.9 miles. At the traffic circle, take the 2nd exit and stay on WI-60 Trunk E (9.7 mi). Continue straight to stay on WI-60 Trunk E (1.6 mi). Follow Co Hwy C to Co Hwy P/Co Rd P in Jackson (4.8 mi). At the traffic circle, take the 2nd exit and stay on Hillside Rd (0.3 mi). Turn right onto Co Hwy C/Co Rd C (3.2 mi). Turn left onto Co Hwy P/Co Rd P (1.0 mi). At the traffic circle, continue straight to stay on Co Hwy P/Co Rd P (0.2 mi) to Washington County Fair Park, 3000 Cty Hwy PV, West Bend, WI 53095
